SET-UP WITH VEHICLE:	7:00 am – 9:00 am	Vehicles allowed at booth. PLEASE DO NOT BLOCK other booths.
GROUNDS CLOSED TO VEHICLES:	9:00 am – 3:00 pm	During this time, vehicles must be in their parking spots. Use hand cart.
EVENT TIMES:	10:00 am – 2:00 pm	Public admission & parking is FREE south of Jefferson St.
STRIKE TIMES:	2:00 pm – 3:00 pm	Once the public leaves and staff okays, vehicles allowed back in.
